When you first think of Interior Design, you probably envision furniture arrangement and knick-knacks positioned on a table. True, basic arrangement is essential, but there is so much more to consider. A Professional Interior Designer works in unison with an Architect, right from inception. Placement of furniture in an area is also essential. If the area feels cluttered, it does not make for an inviting feel for your clients. Pathways and open areas are planned into an overall design, as well as exit routes. Heavy traffic areas require more durable materials, yet must maintain consistent aesthetics. The end result is a professional, esthetically pleasing area with the client's desires always in the forefront.

## SPOTLIGHT Client: Laurie Bisch Bisch Storage Facility

A native Nevadan, GGWArchitects client, Laurie Bisch, was born and raised in the Tahoe area—the youngest of 6 kids. Anxious for a career in law enforcement, Laurie moved to Las Vegas in 1990 and entered the Las Vegas Metro Academy for 18 weeks of training. She graduated with a class of 45 peers and has been protecting our community ever since.

In fact, Laurie is responsible for creating the "Enduro" motorcycle patrol along the Las Vegas Strip. She also founded Operation Make a Difference for our older victims of crime. The program is funded by donations from various companies in Southern Nevada.

You probably recognize Laurie from the many billboards, dotting our streets, during the 2006 race for Clark County Sheriff. Laurie finished with 20% of the votes, overall. There were 16 candidates vying for the position, vacated by Bill Young.

Laurie keeps plenty busy with Metro, as our valley growth has led to an increase in crime. Our ratio of officers for every 1000 people lags behind, despite vigorous recruitment efforts. There are 7 new area commands (substations), including McCarran International Airport and 3 more to be built to help manage our booming population.

When it came time for Laurie to hire an architect for her underground storage facility (over which a tennis court will be built) at her home, there was no question who it would be. Architect Wilson, until he moved last year, was her neighbor across the street. Construction is expected to begin this fall.

### SPOTLIGHT Project: Bisch Storage Facility

A basement facility, such as the one GGWArchitects is designing for Laurie Bisch, is rare "because of sub-soil conditions in Las Vegas," according to Architect Wilson. Although underground, it will meet all "building codes and Planning and Zoning ordinances." An underground hall will connect it to Laurie's house with a tennis court over the space. The space will house an office and a recreational area. The project should be complete 4 months after construction begins.
