## What are the various steps in the bidding process?

Ask The Architect

- A letter of "invite to bid" is sent to a list of selected bidders, along with a request for a "statement of qualifications".
- A bid form package is prepared that consists of plan sets, specifications, bidding instructions, project description and conditions, and the schedule of date and time due.
- A meeting is held and/or private viewing is done of the bids received.
- A review of the bid information, for comparison, is done along with an additional review of the statement of qualifications.
- We present to the owner our findings and opinions regarding both the bid and the bidder.
- The Owner makes an informed decision.
- We then prepare a contract between the owner and the selected contractor.
- Finally, a "construction" commence date is scheduled.














### SPOTLIGHT Client: Robert J. Garlow, P.E. City of North Las Vegas

GGWArchitects is currently awaiting approval from the City of North Las Vegas before construction documents can begin. Jason M. Andoscia estimates this to be around late 3rd Quarter or early 4th Quarter, 2007.
